Potential candidates include:                             <ol style="list-style-type: none"> <li>1. AI and Stop Sign Cameras: The City does not intend for these to be revenue generators, preferring that they reduce accidents and improve the safety of our streets. Given this, what are best practices around the country for utilizing the data collected?</li> <li>2. AI, Surveillance Cameras, and Privacy Rights: As the City deploys more and more Surveillance Cameras and residents record data on their doorbell cameras, what are best practices for utilizing the data collected? This is a more general case of the Stop Sign Camera situation.</li> <li>3. How the Police Department address community challenges and issues resulting from people who are unhoused and living on our streets and</li> </ol> </li> </ul>	

in our parks. What can they do, not do, and what other resources do they engage to help with this growing challenge? As with all our projects, what are best practices in other communities?

4. What resources do residents have access to in order to learn about public safety issues and programs. E.g., the online Daily Crime Report.
5. What statistics are available for police departments across our regional municipalities, and what information can the community and the Department glean from those in order to guide Police and Public Safety improvement efforts going forward?
6. How effective and useful is today's Police Department website, and what changes and improvements might we recommend to make it more useful to community members? What are best practices around the country?
