Re: Survey Services- Driskell, Hyattsville, MD DPW07132015 / JMT #16-1916-071

Dear Mr. Metzler,

JOHNSON, MIRMIRAN & THOMPSON is pleased to offer to provide the City of Hyattsville surveying services for Driskell Community Park located on 40th Avenue and Hamilton Street. Research and field surveying can start immediately after receiving the Notice to Proceed and be completed in approximately nine weeks. JMT is assuming a 10-hour field day for this project. JMT is proposing two survey methods: Conventional survey and Drone survey. In addition, City of Hyattsville, MNCPPC, and WSSC own a proportion of the land therefore, the price is also broken down into percentages.

The scope of work and deliverables will include:

Initial Ground Control: JMT will set and value site control to create a traverse network that will be installed around the perimeter of the project area and be used to locate topographic & boundary features. Horizontal and vertical datum for the project will be referenced to the Maryland State Plane Coordinate System (NAD 83/2011) and a North American Vertical Datum of 1988 (NAVD 88). Control points will be placed in locations selected for longevity and security for the duration of the project and available for future use should that be deemed necessary.

JMT will set 5/8" rebar with a plastic cap noting "JMT TRAVERSE POINT". Each point, situated within open areas, will be located by using a combination of conventional and GPS methods. Primary control points located by conventional methods will adhere to a system of three (3) direct/reverse angles with distances recorded in each direction. Primary control points located by using GPS will be valued by using multiple observations.

Secondary control may be necessary for completion of this project within areas inaccessible by the primary control. Secondary control will be tied into the primary network to minimize errors and identify blunders.

Topographic Surveying: JMT field crews will utilize primary and secondary control to locate ground features to create a topographic worksheet with 1-foot contours. The limits for the survey are shown attached highlighted in purple. These surveys will be completed under the direct supervision of a Maryland Licensed Professional Land Surveyor. These location surveys will include the following:

- Edge of pavement, parking areas, paint lines, and signage along the roadway.
- Poles and guy wires, mailboxes, fence lines and landscaped areas.

- Driveways, access roads, street trees and trees over 24" DBH within a woods line.
- Building outlines & recreational areas.
- Drainage pipes/inlets/structures and retaining walls.
- o Above ground visible utility appurtenances.
- Major changes in grade & ground elevations necessary to produce 1' contours.
- o 1st floor elevations of any permanent structures. (JMT will require access to the structures)

Data Reduction and Processing: Field data will be reduced in the office by a Survey Technician and checked for errors. Field notes, both on paper and electronic, will be compiled and adjusted to create a final traverse. This final traverse will be used to process the field collected topographic features. The raw field data will be processed into an AutoCAD drawing file. All office calculations, drafting, data reduction, and adjustments will be under the direct supervision of a Maryland Licensed Professional Land Surveyor.

Quality Control/Quality Assessment: JMT employs many QA/QC measures to minimize the occurrence of errors inherent to the surveying process. Field collected traverse angles will be observed in a 3 direct/reverse method to minimize angular errors. Primary and secondary traverse lines will be adjusted mathematically to identify and eliminate errors. Field run topo will be inspected by both office and field personnel to check for correctness. Prior to delivery of the final product all deliverables will be checked by a Maryland Licensed Professional Land Surveyor.

Boundary Survey: JMT will perform surveys necessary to establish the boundary lines around the project limits. The limits of the survey are outlined in red on the attached tax map. This boundary contains property owned by the City of Hyattsville, MNCPPC, and WSSC. The necessary deeds, plats and available roadway information will be obtained from web-based services and through courthouse research. This information will be plotted into a field mosaic and will be utilized to search for existing property corners along and near the property boundaries. A traverse will be established at convenient locations within the properties to locate existing boundary markers. The surveys will be referenced to the Maryland State Plane Coordinate System (NAD 83/2011) and under the direct supervision of a Maryland Licensed Professional Land Surveyor. The following is a list of procedures necessary to complete the boundary survey portion of the project:

- o Courthouse records research of tax map, road, deed, plat, and ownership information.
- Plot all appropriate deeds and plats to prepare a deed mosaic to aid in the search for property corners.
- Location of property corners and monumentation from existing traverse.
- Prepare traverse worksheet depicting field survey data and monumentation.
- Review boundary, complete boundary resolution to re-establish boundary lines and prepare a boundary workmap in an AutoCAD format.
- Identify any encroachments, overlaps or gaps in title, or adverse areas which will be of interest to the client.
- Plottable easements and rights of ways withing the boundary will be shown graphically assuming JMT can recover enough field information to accurately depict the limits with confidence. A provided title report could aid in the re-establishment of any easements across the boundary.

Download the current 100-year flood plain firmette map and reference into the boundary.

Subsurface Utility Designation Level C & D Services: JMT will compile a list of utility owners through Miss Utility of Maryland and the MDOT SHA District 3 Utility Engineer. This list will be used to make requests for public utility records. Once received, JMT will create a Utility Composite in AutoCAD for the existing underground utilities throughout the proposed Driskell Park limits, in conjunction with the existing survey provided. In addition to this, if available, JMT will label the following within the composite: utility owner, size or dimensions, and material. The information contained in this CADD drawing will meet the standards that are outlined in ASCE publication 38-02 for the depiction of Quality Levels 'C' and 'D' utility information.

Environmental Investigation/Permitting Support: JMT will conduct field investigations to identify wetlands and waterways within the project area using the procedures detailed in the 1987 US Army Corps of Engineers (USACE) Wetland Delineation Manual and the appropriate Regional Supplement. This includes identifying areas that satisfy the three wetland criteria of hydric soils, hydrophytic vegetation, and hydrology, and recording this information on wetland data point forms. All wetlands and waterways will be flagged in the field using pink flagging, and field surveyed with a handheld Global Positioning System (GPS) capable of sub-meter accuracy. Wetlands and waterways will be incorporated into the base mapping for the project.

Any significant trees, those trees with a diameter at breast height (DBH) of 24" or more, will be surveyed in the field. Notes regarding the species, size, and health of the tree will be recorded as well. The location of each significant tree will be GPS located and incorporated into the base mapping for the project.

- There will not be any change in project area boundaries. If the boundaries of the project area are changed, JMT will submit a scope and budget modification to cover those areas not previously included.
- Investigations, reporting, and consultation for rare, threatened, and endangered species or cultural/historical resources are excluded.
- This scope and fee does not cover wetland and forest permitting services. Any services not mentioned above are excluded from this scope.
- JMT assumes the City of Hyattsville will coordinate permissions for property access.


FINDER Online Map
