





MAJOR CHANGE FUTURE LAND USE MAP






The City contracted with Tanko Lighting to perform an audit of the streetlights in the City. This analysis looked at PEPCO's proposals for municipalities to take streetlight ownership and the proposed costs. They performed a cost analysis of each. Tanko will be presenting the results of this study and a recommended way forward for the City to consider based on their analysis and the results.

Hyattsville, MD Streetlight Rate Update

March 17th, 2025



Jason Tanko CEO





- Tanko Lighting completed a streetlight study in October 2023
- Presented study findings in February 2024
- Compared 4 Options
 - Option 1 Buyout Pepco streetlight system + LED conversion
 - Option 2 Pepco-sponsored LED Conversion
 - Option 3 No buyout, LED conversion with Tanko
 - Option 4 Status quo, no change





- No buyout from Pepco, LED Conversion with Tanko
- Advantages:
 - Highest return amongst the 3 options, \$3.7m over 20 years
 - PEPCO responsible for maintenance
 - Good idea at the time, less realistic with new rates

Streetlight Project Update



- Tanko completed the lighting audit and GIS overlay
- Hyattsville current streetlight bill will increase >10% as of 4/1/2025
 - Monthly bill increases from \$18,650 to \$22,345 this coming April
- PEPCO updated the streetlight rates to make it more favorable for the City to acquire the lighting system
- New rates signal that PEPCO does not want to upgrade fixtures to LED, extremely high costs

- 20yr savings of \$4m between Options 1 and 3 is 7% higher than original idea of Tanko conversion / Pepco own and maintain
- In no scenario should the City entertain Option 2 or 3





- Buyout lighting system from Pepco, Tanko LED conversion
- Advantages:
 - Much lower project costs and ROI
 - LED conversion in <1yr
 - Control over lighting design and maintenance response times
 - Improve nighttime public safety

Streetlight Purchase Authorization

Suggested Action:

I move that the Mayor and Council authorize the City Administrator to negotiate and enter into an agreement with PEPCO for the purchase of streetlights within the incorporated City boundary, pending legal review.

Summary Background:

In the FY 2023 Legislative Session the Maryland General Assembly passed the County and Municipal Street Lighting Investment Act that allows local governments to acquire streetlights from their local electric utility. City staff participated in several group meetings with other municipalities to discuss PEPCO's proposals and costs. Following the meetings, City staff engaged the services of Tanko Lighting to analyze, evaluate, and manage the lighting upgrade process. Tanko presented their initial results to the City Council where it was recommended that the City move forward with an upgrade of the lights with PEPCO maintaining ownership and responsibility for maintenance under a revised streetlight rate tariff.

In late 2024 PEPCO proposed a new streetlight rate tariff. This new rate structure changed the cost of PEPCO owning and maintaining the streetlights. Tanko revised their analysis of the City's costs and these new results show that it would be in the best financial interests of the City to aquire the lights from PEPCO then convert to LED, saving the City an estimated \$4 million over 20 years with an upfront investment of approximately \$1 million. These results and any final agreement with PEPCO would be predicated on Maryland Public Service Commissions acceptance of the currently proposed streetlight rate tariff.

Next Steps:

Negotiate and enter into agreement with PEPCO. The purchase will return to Council for approval of the expenditure.
