- a. The Advisory Committee will vote on whether to recommend to the City Council the following strike through of the language on domestic fowl.
  - i. Proposed language: The Code Compliance Advisory Committee recommends that the Mayor and Council direct the City Attorney to draft an ordinance amending Chapter 52 of the Hyattsville Charter and Code to amend section §52-10 by striking the inclusion of “domestic fowl”, and “poultry and game birds” from the list of prohibited animals. Roosters will remain on the list of prohibited animals in the Code. We recommend that the Council bring this up for discussion before June 2025 (i.e., before FY 25).
