Appeal has been made to this Board for permission to validate existing conditions (net lot area, lot width, lot frontage, front yard, and side yard) and obtain a building permit for the construction of the proposed one-story addition and steps for basement to exit on Residential, Single-Family-65 (RSF-65) Zoned, property known as Part of lot 3, Map 042, Grid A3, Northwest Hyattsville Subdivision, being 3814 Nicholson Street, Hyattsville, Prince George's County, Maryland, contrary to the requirements of the Zoning Ordinance.

The specific violation resides in the fact that Zoning Ordinance Section 27-4202(e) prescribes that each lot shall have a minimum net lot area of 6,500 square feet. Section 27-4202(e)(1) prescribes that each lot shall have a minimum width of 65 feet measured along the front building line, 52 feet measured along the front street line and not more than 35% of the net lot area shall be covered by buildings and off-street parking. Section 27-4202(e)(2) prescribes that each lot shall have a front yard at least 25 feet in depth. Section 27-4202(e)(3) prescribes that each lot shall have a side yard at least 8 feet in width.
