### 5. Public Comment (7:10 p.m. – 7:20 p.m.) Complete Speaker Card, Limit 2 minutes per speaker

Margot Nassau (4000 Hamilton St) thanked the Mayor and members of the Council for meeting with residents about the Driskell Park intersection. She is opposed to many elements within the proposed changes and offered suggestions for this intersection.

Melissa Schweisguth (Ward 5) is opposed to all of the proposed changes at the Driskell Park Intersection. She also asked that the Mayor and Council support the Rent Stabilization Ordinance in 2025.

Eli Braun (Hamilton St) thanked the Mayor and members of the Council for meeting with residents about the Driskell Park intersection. He is opposed to the traffic proposals, stating he feels they will be ineffective, confusing, and will have negative impacts on parking.

Kara Vegas (Hamilton St) thanked the Mayor and members of the Council for meeting with residents about the Driskell Park intersection. She is opposed to many elements within the proposed changes and offered suggestions for this intersection.

Mr. Marshall (Ward 4) is opposed to the funding for playground equipment at "The Spot". He is also opposed to the proposed changes in the direction of traffic in the Driskell Road proposal. Lastly, he thanked Mayor, Council, and staff for their hard work this year.

Daniel Broder (Ward 2) is opposed to the opposed changes at the Driskell Park intersection, but stated a roundabout added to the third option could be suitable. He asked for better safety features such as clearer signage at this location and asked the Council to take up the Rent Stabilization Ordinance and ranked choice voting in 2025.

Will Seath (Ward 2) lives near Driskell Park intersection and is opposed to the preferred alternative as it makes intersection more dangerous and creates problems for emergency vehicles.

**Gallatin Intersection CC Presentation** 

Director of Public Works Lesley Riddle, Transportation Manager Taylor Robey, and Oscar Garcia (RK&K) provided an overview of the Gallatin Street Intersection Study. This study was initiated by a Council request and was subject to a competitive solicitation process in accordance with City guidelines. Items presented to the Council and residents are design concepts that will be vetted by all stakeholders. The goal of project is to improve pedestrian safety and maintain efficient traffic flow.

The Council provided feedback and recommendations on three traffic plan proposals. CM Denes stated opposition to the bike lane between parked cars and traffic as he feel is it unsafe for bikers. CM Schaible reiterated his support for a roundabout and encouraged the staff to do additional research this option. Council Vice President Waszczak also supports installing a roundabout at this intersection and encouraged residents and Council members to explore the roundabout behind Whole Foods in Riverdale, MD. She also asked about adding traffic signals to this intersection. Council President Solomon and CM Strab urged the Council to engage with the community more during this process. Council President Solomon also encouraged implementing immediate remedies such as clearer signage for drivers. CM Haba opposes any plan that would negatively impact parking for residents.
