- 1) Call to Order 4:10pm Present:
 - a. BOSE Members: Zach Peters (Chair), Erin Payne, Lisa Pineda, and Greta Mosher

- 2) Presentation on Rank Choice Voting
 - a. Daniel Broder presented on the concept of Ranked Choice Voting, and what are some of the advantages of Ranked Choice Voting
 - i. Used in Maine, Alaska, NYC, and San Francisco (among other places)
 - ii. In MD, only used in Takoma Park (since 2005)
 - iii. According to FairVote, education about ranked choice voting with the public has not been a hurdle to implementation in other areas
 - b. Chair Peters has a draft copy of the legislation for ranked choice and it can be shared around FairVote has reviewed this legislation
 - c. Any next steps will require the following:
 - i. Support from and consultation with Hyattsville City Council will need to be a majority
 - ii. Input from Hyattsville legal counsel after input from Council legal counsel's hours are billable to the city
 - d. Follow-up questions and thoughts from BOSE and City Staff:
 - i. Will need to better understand the education efforts needed
 - ii. What kind of public comment period would be needed? How could this be incorporated into the tentative survey plans?
 - iii. 2025 city election will likely be too soon for implementation of ranked choice voting
 - iv. In the end, will need to bring back to BOSE for more discussion and need to determine how this would be prioritized relative to other priorities for the BOSE and city elections
- 3) After Action Review, Election 2023
 - a. Poll Pads worked great!
 - i. Only issue was with mobile printers
 - ii. Poll pads were a huge time and training saver
 - iii. Less judges were required to hold election
 - b. Judges they were seasoned and professional went smoothly with this group of judges
 - c. Set up
 - i. Election "swag" table should be further away from exit/ballot scanner
 - ii. No tally sheet with ballot issuing judge table
 - iii. Recommend having a table next to ballot scanner so voters can directly place folder on table without having to hand it to the judge
 - d. Election Fest
 - Recommend that location be further away from actual voting maybe across the street?
 - ii. Extra help from volunteers/staff/etc.?
 - e. Outreach/Communication throwing "just" a voting event doesn't draw people maybe consider tacking on to another event or re-branding it as another/additional event

 - i. Dan Broder and T. Carter Ross brought it to BOSE and wanted to present
 - b. Citizen is interested in joining the Education or Environmental Committee
 - c. What is the process for placing a ballot question for the next election?
 - i. City staff clarified that Hyattsville City does not administer county elections, and would not be able to add ballot questions to that election
 - ii. Ballot questions need to be on a particular topic and within city jurisdiction/control/authority allocation of federal funds does not fall under this
 - d. Ranked Choice POV: Candidate with plurality should win shouldn't need majority
 - e. City staff helped citizen to talk through other issues not related specifically to Board of Elections
