- i. Guest Presentation from Joe Paul, Founder & CEO of OptimaNova AI Corp.
 1. AI can improve local services
 2. Important to be ethical, equitable and community focused
 3. Presentation outlined best practices and recommendations
 4. Opportunity for questions and comment from Chief, Police Chief, Councilmembers, and others
 - a. Recommendations of other jurisdictions doing this well: Detroit, MI has a powerful AI code of ethics
 - b. Councilmember Strab- recommends the committee look into an AI Code of Ethics to ensure consistency.
 - c. Bob recommended we, as a committee, draft an AI code of ethics and an AI data privacy code.
 - d. Taurean provided a useful document from the University of Michigan with sample templates for codes. He will send the resource to the group.
 - e. Patricia recommended the National Science Foundation as a resource. They are key researchers in this field.
 - f. Chief requested that we focus on Police and Public Safety recommendations.
