The following represents the cost to furnish all labor and material items for the above referenced job. Included in the costs shall be the Removal and Hauling of all Fence Debris associated to this installation. We will Cut Off the Existing Fence Posts at the Grade Just above the Concrete Footers.

<u>Item #1- Replace Perimeter Fence</u> - We will Remove and Replace approximately 500 Linear Feet of 6' high #9-gauge Galvanized Chain link Fence with 3-strand of Barbwire. Included on the Fence will be a Top Rail and #7ga Galvanized Coil-wire Bottom for added strengthen. We will also Include 2-6' Wide Matching Pedestrian Gates with a Page Type Latch for an Owner Supplied Pad-lock.

Fence specifications to include the following:

- #9-gauge x 2" BK Galvanized Chain link fabric.
- #7-gauge Galvanized Coil-wire Bottom.
- 2" OD SS40 Galvanized Pipe-Line Posts set in concrete.
- 2 ½" OD SS40 Galvanized Pipe Terminal Posts set in concrete.
- 3" OD SS40 Galvanized Pipe Pedestrian Gate Post set in concrete.
- 1-5/8" OD SS40 Galvanized Top and Brace Rail.
- All Pipe and Framework to be SS40 Commercial Grade SS40 Galvanized Pipe Material.










Fence and Gate Locations

Purchaser assumes liabilities and indemnifies Hercules for damage to unmarked underground utilities, sprinklers or construction and for damage where fence coincides with marked utility line that cannot be avoided, hidden obstacles which cannot be pre-determined and require additional labor will require an additional charge. In the event purchaser defaults nonpayment terms the full amount shall be due immediately. Past due payments will be subject to a delinquency charge of 2% per month, purchaser agrees to pay all costs of collection including attorney's fees 0f 33% of the amount referred. This contract may be withdrawn if not accepted in 3 days of date written due to manufactures price increases. All deadlines are weather permitting. This Fence and Pedestrian Gates and will carry a one-year warranty against defects in workmanship and materials from the date of completion.
