4 5 6 7 8 9	A resolution authorizing the City of Hyattsville to negotiate the renewal of the Franchise Agreement with Verizon Maryland, Inc., and to join Prince George's County and other municipalities in negotiating the renewal of the Franchise Agreement with Verizon Maryland, Inc.
10	WHEREAS, the Mayor and Council have authority pursuant to Maryland Code, § 1-
11	708(c) of the Local Government Article to regulate cable television franchises within the City;
12	and
13	WHEREAS, the Mayor and Council have authority pursuant to Chapter A125 of the City
14	Code to regulate cable television franchises within the City; and
15	WHEREAS, the City previously entered into a Franchise Agreement with Verizon
16	Maryland, Inc., hereinafter referred to as "Verizon;" and
17	WHEREAS, the term of said Franchise Agreement ends in 2022; and
18	WHEREAS, the City received a letter from Verizon wherein Verizon invoked the formal
19	renewal provisions of § 626 of the 1984 Cable Communications Policy Act; and
20	WHEREAS, Verizon's aforementioned letter also indicated Verizon's desire to engage
21	in an informal process of negotiation; and
22	WHEREAS, the City is required to perform a needs assessment as part of any
23	renegotiation of a franchise agreement; and
24	WHEREAS, it is in the public interest that the City enter into franchise renewal
25	negotiations with Verizon; and
26	WHEREAS, the City has been invited to be part of a joint negotiation with Prince
27	George's County and other municipalities to negotiate the renewal of the Franchise Agreement
28	with Verizon; and

1	WHEREAS, the City participated in a similar joint negotiation with Prince George's
2	County and other municipalities when the Franchise Agreement with Verizon was first reached
3	and received the benefit of pooling its financial and other resources to reach an agreement that
4	was acceptable to the City; and
5	WHEREAS, the Mayor and Council have determined that it is in the public interest to
6	join with Prince George's County and other municipalities in negotiating the new franchise
7	agreement in order to allow the City the benefit of pooling its financial and other resources to
8	perform the needs assessment and to negotiate the renewal of the Franchise Agreement with
9	Verizon.
10	NOW, THEREFORE, BE IT RESOLVED that the City of Hyattsville, Maryland, has
11	determined it is in the public interest to perform a needs assessment and to negotiate the renewal
12	of the Franchise Agreement with Verizon. The City of Hyattsville will therefore join with Prince
13	George's County and other municipalities in performing a needs assessment and in the
14	negotiation process. City staff is authorized to take those steps necessary to participating in the
15	negotiation process.
