- It is the last day of Black History Month. Updates
  - Feb. 17th (West African storyteller, leader of community) hosted who presented

the Passage to Freedom, a set of African American folktales.

- Topics discussed during the Budget and ARPA meetings that may align with our RETF work include a potential Hyattsville circulator bus, community policing initiatives, potential hiring of a housing manager.
- The City has invested in learning opportunities for leadership-level on
   Government Alliance on Race and Equity. There is a DMV learning cohort for
   Directors that will participate in a year-long cohort.
- Follow up from Native American and Indigenous History Month one of the panelists is taking the lead to organize a powwow with the University of Maryland on March 11th from 11am-5pm at UMD.
- CM Denes: The housing manager proposal, sponsored by CM Waszczak, envisions someone who would oversee all of our affordable housing plans and follow up with the housing plan that was drafted in 2019. Mount Rainier just passed a housing rental stabilization bill, limiting the year-over-year increase in rents. Tonight, PG Council was hearing and possibly voting on a similar, though temporary, measure. HVL City Council has started to discuss implementation of our own, which would require certain staff levels.
- Liaison SL: One comment that came up during discussion was that similar to the ways the City has prioritized equity, this hiring would give this urgent issue its due weight.

# 7:46 pm - 8:25 pm – Reproductive Justice Sanctuary City Bill Presentation and Discussion

  - National context: As of today, abortion is fully illegal even in cases of rape and incest –
    in 12 states and has hostile restrictions in 12 states. Following the *Dobbs* ruling, some
    states have expanded access to abortion, some codifying into the state constitution.
  - History of bill: Three previous drafts. Draft bill sponsored by CM Denes, Schiable, and CM Waszczak.
    - Stop police force from collaborating with law enforcement agencies to enforce laws that would prosecute gender-affirming care or abortion care.
    - Anticipate a public hearing in English and Spanish.
  - Co-Chair Freemyn: What kind of feedback would be helpful? Are there any communities you haven't heard from yet? How do you want to receive feedback?

- KR: Would this proposed legislation limit police to not comply only for issues around reproductive/gender affirming care?
- Co-Chair Freemyn: There is precedent in HVL with HVL police have not collaborated around immigration issues with ICE sanctuary city.
- DA: Why is it that the bill would stop at law enforcement agencies and not ask that health providers operating within HVL adhere to this law?
  - HIPPA may protect that activity. This would add another layer of protection by disincentivizing the prosecution of people seeking gender-affirming care or abortion care.
- RETF can add this to next month's agenda to provide comments and will check in on timeline.
- Community member raised concern that there may be too many restrictions on HVL police and may affect their ability to do their jobs.
