 - Update from Ben: The <u>Better Bag Bill measure</u> is looking likely pass in PG Co legislature. Would go into effect starting Jan 1 2024. Potentially stricter than what Hyattsville was considering for a City measure.
 - The City of Hyattsville has sent a letter of support to the county.
 - Opportunities for the City of Hyattsville to engage in education campaigns to raise awareness about the ban for greater compliance
 - Will be good to see how the county rollout goes; do we need more compliance/enforcement? This could inform whether we decide to move toward our own City ordinance. No action needed at this point.
