- 1. Amend/Approve minutes from November Meeting
  - a. Motion to approve, Don. Brittany seconded. Unanimous approval.
- 2. Meeting Calendar 2024
  - a. Peter motioned to move the November and December 2024 meetings to the third thursday, Don seconded. Unanimous approval.
- 3. Election of Chair & Recordkeeper
  - a. Nicole motioned for Peter to be recordkeeper, Erica seconded. Unanimous approval.
  - b. Nicole motioned for Marylyn to be the Chair, Don seconded. Unanimous approval.
- 4. Speaker Series:
  - a. Cooking class December 9 Follow-up
    - i. Four people attended, despite Cheri receiving confirmation from ten people.
  - b. Forestbathing December 2 Follow up
    - i. Erica attended. 11 people participated and it was very well received. The facilitator Anna did a great job. Erica discussed with Anna potential future events involving those with disabilities.
  - c. Self Defense
    - i. Marylyn contacted Berwyn Heights Brazilian Jiu Jitsu. They would be able to host a self defense class for up to 20 people for \$150. We would need to provide a space and the city would have to sign a liability waiver.
    - ii. Main floor of the city building would be an option to host an event.
