2. Staff Liaison/Member Updates

- General HVL & PGC Update (Jan)
 - MD: 66.7% PGC: 64.5%
 - o HVL: 57.6% -- we've been fairly static for 8 weeks

County news

- Trump announcement that they wouldn't count undocumented immigrants
- Word from US Census Bureau: going back to Judge Furman from SDNY who presided over citizenship question case
- Making a case that this is a violation of the original SCOTUS ruling
- Very high confidence that the ruling would go in their favor
- HOWEVER damage to perception by undocumented members from hard to count/foreign born populations
- This is a POPULATION count NOT a citizen count emphasize this to the extent possible

Apartment Complex Updates / Assignments (Matt)

- Great swag from Census thanks to Steven
- Matt and friend made swag bags
- o Can't show them because video disabled on Zoom call
- Will be planning drop offs soon
- Will need help with logistics
- Christine may take over signs (last meeting); may be able to help coordinate bag distribution
- o 25 signs left at Jenn's home
- Next wave of signs with new branding

- Consider removing/moving old signs and replacing them with new ones
- We're on the agenda for the Aug apt managers meeting (Jan)
- Budget check: \$12K left (Matt/Jan)
 - o \$1275 for 200 signs and stakes for 1 version
 - we were undercharged for big belly signs; this means if we do another run it will cost us more

MOTION

- Authorize \$5000 towards three different types of signs (Matt)
- Seconded (Patrick)
- Approved unanimously
- Going Deeper into School/Faith Targets (Jenn & Matt)
 - Apt complex, middle school, adult ed, faith-based networks will become even more important – need to be a community member that these hard to count populations would trust; need an ambassador
 - Food distribution outreach netted four folks who needed help;
 Steven able to help three (one had a bad phone number)
 - Think about breaking down into more strategic subcommittees so it doesn't all fall on Matt
 - Without Leanne, don't currently have any school outreach/contacts – they're gearing up to start a fully remote fall – think about how to reach that demographic
 - Christine would be a good fit for grade/middle school (but not here today)
 - Need someone else for post secondary/higher ed
- No business update (Patrick)
 - Next business roundtable is unknown at this time
- Video Contest Launch (Jenn)
 - Status & Updates
 - Steven took video of Jenn; haven't seen it yet
 - Need to get contest rules out there; video can go out after the fact
 - County also has a ton of video that might be relevant/can be repurposed
 - City attorney (Skip) about whether the rules and regs are approved; communications staff is ready to flip the switch

 would love to have Tracey Douglas announce this at the Monday Council Meeting
 - Ready to go as soon as Skip approves

- Alissa can start working on comms Jan to send finalized language to Alissa; emphasize population check NOT citizen check
- Counting on committee members to promote/share this content;
 consider a video or something similar to share/gain traction

 - Nancy is happy to volunteer on a subcommittee wherever she's needed most; doesn't speak Spanish → probably will get help with apt outreach (Matt)
 - Status of mailer: money approved, but design is not hammered down
 - Jan & Alissa to work with designer run by Matt/Jenn to approve
