WHEREAS, the hope is that asking will become a common health and safety question, offering an immediate solution that all Americans can adopt to help protect their families and children from injury and death; and

WHEREAS, the power of the ASK Campaign is that it brings together all Americans concerned with the welfare of children, including gun owners, and makes the solution to gun violence a discussion about public safety and good parenting; and

WHEREAS, the first day of summer, the season in which kids typically spend more time at the homes of friends and family, is designated as National ASK Day;

NOW, THEREFORE BE IT RESOLVED, that the Mayor and Council declare June 20, 2021, to be National Ask Day in the City of Hyattsville.

I move that the Mayor and Council adopt Hyattsville Resolution 2021-05, a Resolution whereby the City Council declares a vacancy on the Council in Ward 1, notifies the Board of Supervisors of Elections (Board) to fill the vacancy, and declares the City's 2021 special election for Ward 1 to be a Vote-by-Mail election.

Summary Background:

The City's Biennial election held in May 2021 yielded a vacancy in Ward 1. A special election will be held to fill the remainder of Kevin Ward's term through May 2023.

Based on the successful completion of the City's first Vote-by-Mail election and the significant increase in voter turnout, the Board of Supervisors of Elections recommends the City Council designate the special election as a Vote-by-Mail election.

The Board has designated Election Day as Tuesday, September 14, 2021. The Board is in process of securing vendors for the special election. Candidate registration is tentatively scheduled to open on Monday, July 5 and close on Friday, July 23.

Next Steps:

The Board and City staff will proceed with planning and executing the Ward 1 Special Election.

The FY22 Election budget is approximately \$50,000.

WHEREAS, the Mayor and City Council deem it in the best interest of its residents to conduct a vote-by-mail election for the Ward 1 special election pursuant to the City Code.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Hyattsville in regular session assembled that there is a Council vacancy in Ward 1 and the Board of Supervisors of Elections shall proceed to fill the Council vacancy in Ward 1 by conducting a special election in accordance with the City's Charter and Code; and

BE IT FURTHER RESOLVED, by the City Council of the City of Hyattsville in regular session assembled that the City's 2021 special election for Ward 1 will be a vote-by-mail election.
